Notice is hereby given that on **October 26, 2023** the City of Valley View Board of Aldermen, Valley View, Texas will hold a Regular Meeting at **6:00 PM**, in the Valley View City Hall, located at **101 S. Frontage Rd., Valley View, Texas**. **Should anyone wish to address the Board on any agenda item, they must arrive prior to the meeting and sign in.**

1. **Call meeting to order, announce quorum, and welcome** – Mayor Bewley

3. **Public Comments**

This is the opportunity for the public to address the Board on any matter on the agenda, except public hearings. Comments related to public hearings will be heard when the specific hearing begins. Comments related to non-public hearing items will only be heard at this time. Public comments are limited to three (3) minutes per speaker, unless otherwise required by law. To address the Board, you must have signed in prior to the start of the Board Meeting. The Board is not permitted to take action on or discuss any item not listed on the agenda. The Board may only: (1) make a statement of fact regarding the item; (2) make a statement concerning the policy regarding the item; or (3) propose the item be placed on a future agenda.

4. **CONSENT ITEMS:**

All items on the consent agenda are considered routine by the Board of Alderman and will be enacted with one motion unless a member of the Board requests separate discussion of one or more items. In such event, the item(s) will be removed from the consent agenda and considered in sequence as listed.

A. Approve minutes from the Regular Held Meeting held on October 12, 2023.

B. Approve the addition of Susan Raabe as a signature on all active accounts at First State Bank for the City of Valley View.

5. Discuss and take appropriate action to utilize the square for cooking and possible corn hole tournament.

6. Hold a discussion and receive staff reports for future adoption of a landscape ordinance.


7. Hold a discussion and receive staff reports for future establishment of an on-site sewage facility.
