

Minutes of Special Meeting of the Board of Alderman For the city of Valley View, TX April 30, 2025

SPECIAL MEETING – Convene at 6:00 PM

- 1. **Call meeting to order, announce quorum, and welcome** Mayor Bewley called the meeting to order at 6 pm on April 30th and declared a quorum. Alderman presents include Chris Strawn, Todd Haymaker, Joe Wilkerson, Chris Heisler and Sandy Scoggin.
