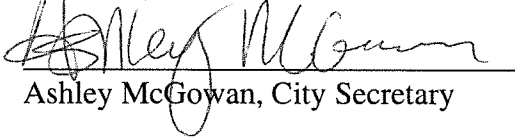
16. Discuss and take appropriate action on amendment to agreement with Lori Cannon, CPA, for additional scope of work.
