O'Buch St., Valley View, Texas. Should anyone wish to address the Board on any agenda item, they must arrive prior to the meeting and sign in.

SPECIAL MEETING

- 1. Call meeting to order, announce quorum, and welcome Mayor Strawn
- 2. Conduct a public hearing and receive comment regarding the proposed 2025 property tax rate of \$0.163949 per \$100 of assessed valuation on taxable property within the incorporated limits of the City of Valley View.
- 3. Discuss and take appropriate action regarding an Ordinance levying taxes and fixing and adopting the tax rate on all taxable property within the corporate limits of the City of Valley View at the rate of \$0.163949 per one hundred dollars (\$100.00) assessed value; and providing an effective date.
- 4. Discuss and take appropriate action regarding a Resolution acknowledging and ratifying that the adoption of the Fiscal Year 2025-2026 Annual Budget will require raising more revenue from property taxes than in the previous Fiscal Year and ratifying the property tax increase reflected in the Budget; and providing an effective date.
- 5. Adjourn.

NOTE: The Board of Aldermen reserves the right to meet in Executive Session, closed to the public, at any time in the course of this meeting to discuss matters listed on the agenda, as authorized by the Texas Open Meetings Act, Texas Government Code, Chapter 551, including §551.071 (private consultation with the attorney for the City); §551.072 (discussing purchase, exchange, lease or value of real property); §551.074 (discussing personnel or to hear complaints against personnel); and §551.087 (discussing economic development negotiations). Any decision held on such matters will be taken or conducted in Open Session following the conclusion of the Executive Session.
