The Board may only: (1) make a statement of fact regarding the item; (2) make a statement concerning the policy regarding the item; or (3) propose the item be placed on a future agenda.

- 6. Discuss and take appropriate action on KJE recommendations on the TCEQ Wastewater permit renewal.


7. Discuss and take appropriate action on KJE recommendations to accept Clay Ranch Subdivision as complete.
